2. Mission & Vision

Mission

To empower individuals and communities to live with freedom, purpose and positive impact — while democratising support for meaningful initiatives globally.

Vision

A world where:

- People reclaim autonomy over how they choose to live, learn and connect.
 - Crypto becomes a tool to fund real impact, not just speculative profit.
 - Communities, not corporations, have a voice in how resources are directed.

3. Problem Statement

Despite rapid blockchain adoption, many crypto projects fail to deliver genuine real-world benefit.

Common issues include:

- Lack of transparency
- Disconnect between promises and action
- No direct purposeful impact

- Community excluded from meaningful decision-making

Good Empire UK fills this gap by delivering real impact funds tied directly to token activity, and by documenting every initiative publicly.

4. The \$GOOD Token

Overview

\$GOOD blends community culture with actionable purpose — fuelled by transactions that generate real resources for positive initiatives worldwide.

Key Features

- Purpose-Driven: A percentage of every transaction is allocated to impact funds.
- Community Governance: Holders participate in voting on supported causes.
- Documented Action: Real-world work is tracked and shared via social channels.
- Built on BNB (BSC): High-speed, low-fee carbon-efficient infrastructure.

Token Utility

\$GOOD holders benefit from:

- Voting on community initiatives
 - Access to exclusive content, community meet-ups and events & educational resources

5. Tokenomics

Total Supply: 100,000,000 \$GOOD

Fair Launch

- Fund the mission, with 80% of raised funds going to a locked liquidity pool.

Team

- A modest allocation to support the team, encouraging long-term commitment and growth. Tokens locked for 12 months, then vested over 12 months for responsible management.

CEX

- Reserved for future exchange listings to increase visibility and adoption. Tokens locked for 6 months before release.

Community Rewards

- Rewards loyal holders and active community members. Tokens vest gradually over 24 months.

Marketing

- Builds brand awareness and partnerships. Locked for 2 months, then vested over 12 months to grow reach while avoiding market disruption.

Social Impact Reserve

- Reserve to boost Good Project initiatives alongside tax funding. Locked for 3 months, then vested over 24 months. Community voting will guide select decisions. Transparent spending to protect price stability and ensure sustainability.

Growth & Development

- Supports brand development, infrastructure and growth. Locked for 3 months, then vested over 12 months for sustainable progress.

Tax

A 5% tax on buy & sell transactions ensures sustainable funding:

- 50% → Real-world impact initiatives
 - 50% → Operational growth, sustainability & ecosystem development

6. Impact Model

Good Project - “Do More Good” Initiative

Every \$GOOD transaction contributes to a pool of resources dedicated to Good Project:

- Community empowerment projects
- Homeschooling & self-directed learning tools
- Sustainability & wellbeing programs
- Partnerships with global organizations in need

All initiatives are selected through community voting, and progress is shared openly with holders.

7. Community & Lifestyle Integration

Good Empire UK goes beyond tokens — it’s a lifestyle movement. The founders are documenting their journey living and traveling in a converted coach — used as a mobile HQ and promotional platform to:

- Engage with communities directly
 - Host meetups and educational events
